# Recommendations by the Steering Committee from the 1<sup>st</sup> Steering Committee Meeting of the MEA IKM Initiative

### The IKM Steering Committee recommends:

#### I InforMEA

- 1. That the IKM Working Group continue to further enhance and develop InforMEA based on the proof of concept project;
- 2. That IKM Working Group seek funding to further enhance and develop of InforMEA;
- 3. That the IKM Working Group examines the technical issues related to the long-term hosting of InforMEA.

# **II Controlled Vocabulary**

- 4. That the controlled vocabulary be used to automatically index and tag MEA information available to the InforMEA portal;
- 5. That items from COP agendas be mapped accordingly, integrated into the controlled vocabulary and used to organize information registered on the InforMEA portal;
- That the IKM Working Group continues to further develop the controlled vocabulary;
- 7. That all members to the IKM Steering Committee participate in the development of and consider the use of the controlled vocabulary.

#### **III IKM Toolkit**

- 8. That the IKM Working Group develop the IKM Toolkit to facilitate the development and maintenance of and participation in the InforMEA gateway;
- 9. That the IKM Toolkit be used to document the formats, protocols and standards, and other relevant information, used to develop and maintain the InforMEA portal;
- 10. That the IKM Working Group examine possible formats for the IKM Toolkit, including, but not limited to, Wiki, PDF, HTML, MS Word;

# **IV Terms of Reference of the IKM Steering Committee**

11. That the Heads of Conventions endorse the Terms of Reference of the IKM Steering Committee.

# **V Capacity Building**

- 12. That the Working Group examines possible mechanisms and collaborative opportunities to enhance technical capacity at the MEA Secretariat level.
  - a. Such mechanisms and opportunities may include, but not be limited to: shared technical resources, subject to the availability of funding, and a shared technical environment (database, CMS, source codes, etc.);
- 13. That IKM Steering Committee members continue to share expertise and assist other participating MEAs, as appropriate.

### VI On-line Reporting:

14. That a Working Group on National Reporting be established to examine expertise and discuss issues related to the development and use of online reporting systems;

#### **VI MEA Academy**

- 15. That MEAs submit information on their capacity building activities and resources to the Working Group for possible inclusion in the InforMEA gateway;
- 16. That the interested members of the Working Group examine issues related to the establishment of an MEA Virtual Academy.

#### VII Funding Strategy:

- 17. That the IKM Working Group and DELC develop a strategy towards sustained financial resources and identify potential donors;
- 18. That UNEP, UNESCO and FAO and the MEA Secretariats consider making the activities of the IKM initiative part of their regular budgets.

# **VIII Strategic Vision**

19. That interested members of the IKM Working Group and DELC draft a strategic vision document for review by the IKM Steering Committee.
