First meeting

#### MINUTES OF THE MEETING

- 1. A meeting of the Bureau of the seventeenth meeting of the Conference of the Parties was held at the *Mexico* Room of the headquarters of the Food and Agriculture Organization of the United Nations in Rome on 28 February 2025 from 4:00 p.m. to 5.15 p.m. local time (GMT+1).
- 2. The purpose of the meeting was to provide the COP Bureau with an overview of the work to be conducted during the biennium by the subsidiary bodies that it serves as bureau, including the scheduling of the meetings and the items to be addressed, and to consider the work plan for the COP Bureau.

### ITEM 1. OPENING OF THE MEETING

5. The meeting was opened at 4:00 p.m. local time (GMT+1) by Her Excellency, Ms. Maria Susana Muhamad Gonzalez, President of the Conference of the Parties.

### ITEM 2. ADOPTION OF THE AGENDA

- 6. The COP President introduced the provisional agenda for the meeting.
- 7. There being no objections, the agenda was adopted.

# ITEM 3. MATTERS TO BE ADDRESSED BY THE SUBSIDIARY BODIES SERVED BY THE COP BUREAU DURING THE BIENNIUM

- 8. Noting the discussion held in the preceding joint meeting of the COP and SBSTTA Bureaux on the biennial work programme, including on the scheduling of the meetings of the subsidiary bodies and matters to be addressed by the Subsidiary Body on Implementation (SBI) and the Subsidiary Body on Article 8(j) and Other Provisions of the Convention on Biological Diversity Related to indigenous peoples and local communities (SB8J), the President focused discussion on the work of SBI, in particular on determining the need for either one or two meetings of the SBI.
- 9. The budget adopted for 2025-2026 makes provision for one meeting of SBI that, because of the timeline for the preparation of the global review of collective progress (whose related decision has now been adopted), will be held back-to-back with SBSTTA-28 in July/August 2026. It had been noted that the intersessional work on resource mobilization arising from the related decision may not require an additional meeting of SBI based on the decision adopted by COP in Rome, and that the potential benefit of convening two meetings would need to be determined on the basis of the overall workload of the SBI. Options for an additional meeting could be back-to-back with SBSTTA-27 and SB8J-1, 1-5 November 2025 in Panama City, or as a stand-alone meeting early in 2026, in Montreal.
- 10. Bureau members discussed pros and cons of these options, including budgetary implications and the amount of work that could be ready for consideration by SBI at a meeting held earlier than August 2026. Some members also addressed potential logistics challenges for small delegations to attend three subsidiary meetings consecutively.
- 11. The Bureau requested the Secretariat to provide an analysis and timeline of all the intersessional work that needs to be conducted on the various matters that will be considered by SBI prior to COP 17 in order to determine what matters could be taken up by SBI at an earlier meeting and what

matters would need to be deferred to its meeting in August 2026. Based on that, the Bureau could consider and decide the way forward through online consultations and an online meeting before the end of March.

## ITEM 4. CONSIDERATION OF THE WORK AND FUTURE MEETINGS OF THE COP BUREAU
