
I. The Island Biodiversity Programme of Work (PoWIB)

- Adopted March 2006 by the Conference of the Parties (COP) to the Convention on Biological Diversity (CBD) at its eighth meeting, in Brazil, (decision VIII/1) (developed 2004-2006)
- The first-ever programme of work dedicated solely to the uniqueness and fragility of island biodiversity (a space for islands)
- Engages both island countries and countries with islands



Programme of Work on Island Biodiversity: Provides a voice for islands within the CBD

One-stop shop on the Convention for island Parties – objective is not to duplicate tasks

- 11 goals, 22 targets, 50 priority actions, seven focal areas:
- 1. Protect the components of biodiversity (10% of all ecosystems, protected areas network, traditional crops, gene banks)
- 2. Promote sustainable use (production and consumption, trade)
- 3. Address threats to biodiversity (loss and degradation, invasives, climate change and pollution)
- 4. Maintain goods and services from biodiversity to support human well-being (disaster plans, health, poverty alleviation)
- 5. Protect traditional knowledge and practices
- 6. Fair and equitable sharing of benefits arising out of the use of genetic resources (ABS Nagoya Protocol)
- 7. Ensure provision of adequate resources (new and additional pipelines, technology transfer and development, strengthen capacity)



The Partnership pursues three long-term goals:

- Support successful implementation of partner commitments.
- 2. Catalyze new commitments to address critical island issues.

In 2010 the Global Island Partnership focused attention on the advancement of two broad themes:

- Ecosystem-based adaptation and mitigation with invasive species; and,
- Integrating conservation and sustainable livelihoods into development processes.

The Partnership supports participating countries and organizations that share in its mission by inspiring and recognizing commitments; strengthening implementation; mobilizing resources; promoting collaboration; increasing visibility and communications; and tracking progress.

Global Island Partnership - GLISPA

- 20 Parties to the Convention, major NGOs and multilateral organizations
- Mechanism to implement the POWIB (2008)
- Launch at COP 8 in 2006, Chaired by Presidents of Palau and Seychelles
- Global Coordinator hosted by IUCN Washington and Communications Manager hosted by PCI-Media Impact New York
- Commitments of over USD 100 million projects (Micronesia and Caribbean Challenges, Coral Triangle Initiative, Global Islands Database, SeaLevel Rise Foundation, Western Indian Ocean Coastal Challenge and national commitments from Ecuador, Croatia, Kiribati and so on)
- High-level island events at COPs 8, 9 and 10, Summit at COP 11, side events, Rio Conventions Ecosystem Pavilion, high level events at UNGA
