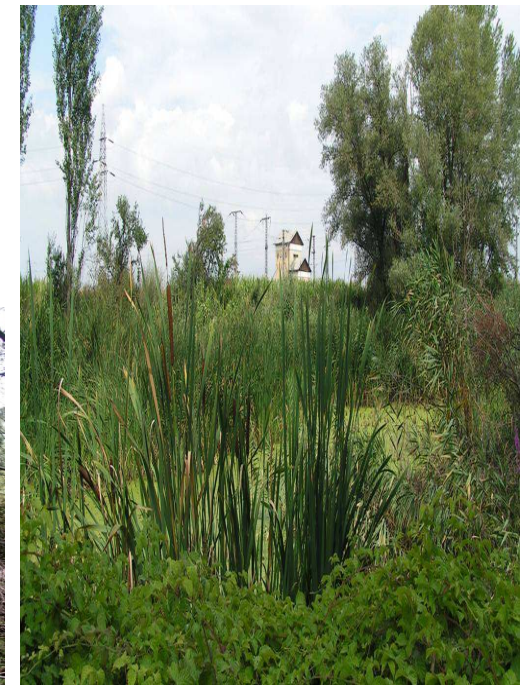
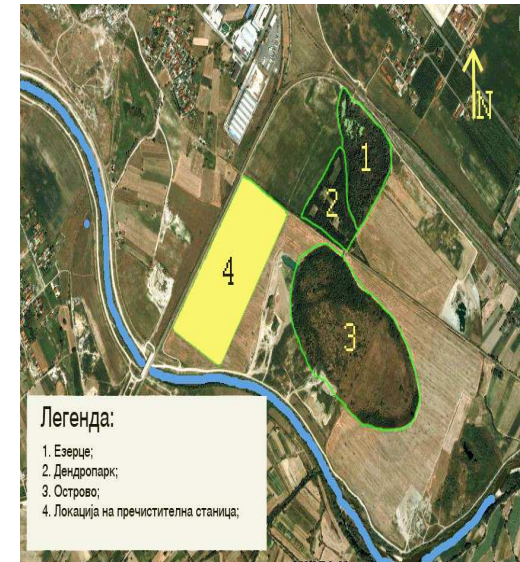

Highlight reviews of 1st NBSAP

Important reviews of 1st NBSAP

- Periodical, annual and thematic reviews made by DBD, SN,
- Selected data for preparation of National Reports for implementation CBD, CMS, RCW, BC/CE, CITES,
- Selected data for preparation Integral Report of implementation 1st NBSAP in March 2009,
- Preparation of Summary of Integral Report for 1st NBSAP, obligation from Macedonian Government (April 2009)
- Identification of the main gaps (DBD and Scientific institution, May 2009),
- Preparation of Draft framework for 2nd NBSAP (2009-13) by DBD and NCBD and sent to 50 relevant institution and organization involved in this process.
- Selected data for preparation 4th National Report of the implementation CBD in RM



Overview of the status of implementation of 1st NBSAP

Progress has been noted in:

- Identified obstacles: insufficient capacity building, education, limit of financial resources, loss level of public awareness, etc.
- Examples of process of the implementation of 1st NBSAP: good cooperation with four National Committee in preparation of National Reports for implementation of CBD, CMS, RCW, FCCC, preparation of Master Plan, four Regional Plans (MEPP, SDPP),
- Case studies: Evaluation of BD in 10 protected areas, preparation of NEAP-2, evaluation of endangered plant species, bird (vultures), mammals (lynx, bear, lutra)
- Contribution of achievement 2010 target prohibition of hunting of threatened animal, total prohibition of fishing of Ohrid salmos, reintroduction of endemic fish in rivers, lakes and wetlands, farming production of therrestrial turtles and gastropods.



Introduce of communication, education and public awareness in the 1st NBSAP

- Internet connection, web-site,
central data-bass of biodiversity,
- Registers, catalogs of species,
- Central monitoring system,
- Programmes for education
(schools, university, institution)
- Activities of public awareness
(institutions, NVOs, media)
- Publication for biodiversity
conservation (books, lefflets, CD)
- eco-campaigns, training,
seminars, workshops, ankets.



The further needs and challenges for best implementation of NBSAP

- Strengthening of capacity building in national and local level,
- Ensuring financial resources for implementation of NBSAP,
- Improving communication (NSC),
- Improving education (NSE),
- Increasing public awareness (SPA)
- Challenges: implementation of Joint programmes for sustainable use of bio-resources (balance between trade and BD protection), projects for reduction in BD loss, Economy and Financial crisis, poverty, indigence in this region, illegal trade, hunting and fishing.
