




### Update on the UNEP Support to GEF Eligible Parties for the Revision of the NBSAPs and Development of Fifth National Report to the CBD

The Convention on Biological Diversity (CBD)Conference of the Parties (COP) 10 decision X/2, requested UNEP and other international organizations to support the implementation of the **Biodiversity Strategic** Plan 2011-2020 beginning with the National **Biodiversity Strategy and Action Plans** (NBSAPs) revision process, and to commence its implementation by 2014.



## Checklist of Important issues addressed in NBSAP updating projects

- 4. Setting national targets, principles, & priorities of the strategy (subnational consultations)
- 5. Development of Action plans
- 6. Biodiversity Indicators (WCMC/BIP)
- 7. Integration and sectoral mainstreaming
- 8. NBSAP Implementation plans for : capacity development, technology needs, resource mobilization, Communications.
- 9. Mainstreaming gender (guidelines, CBD website)
- **10.** Mainstreaming Synergies with biodiversity-related MEAs
- 11. CHM
- **12.** Monitoring mechanisms
- 13. Fifth National Report , deadline March 2014



## UNEP Regional MEA FOCAL POINTS support services



1972-2012: Serving People and the Planet

- 1. provision of regionally-specific technical advice and support
- 2. regional (and possibly national) rollout of central/global activities
- 3. liaison with country focal points
- 4. liaison with other biodiversity-related Convention secretariats on synergistic approaches at the regional level
- 5. liaison with UNDP offices and other entities supporting NBSAPs: IUCN, UNEP-WCMC, LAS, ROPME, FAO...etc



## Countries supported by UNEP

- UNEP is supporting 76 countries in total
- 57 countries in the umbrella set up – Phases I &II
- UNEP is also supporting 19 stand alone countries
- All countries getting \$220,000 (except a few)

- Mauritania 1<sup>st</sup> Cash Advance of \$22,000 on 04-April-2012.

## Some country updates NBSAPs Enabling Activities GEF project



#### Iraq

- 1<sup>st</sup> NBSAP, 5<sup>th</sup> NR. (GEF funding \$368K, cofounding \$405K)
- UNEP stand alone project, legal instruments PCA (UNEP-MOEI) signed June 2012.
- First planning meeting Amman July 2012, draft operational work plan awaiting budget approval.
- Activities focus on: stocktaking & assessments, gap analysis, BD indicators, awareness, capacity building (need assessment), international experts, CHM, sectoral mainstreaming and integration into poverty strategies and CC and other emerging issues (invasive species, dust storms, desiccation of river basin), ratification and synergies with other MEAs..etc.
- Implementation plans
- ROWA: Co-Executing agency, in kind technical guidance and advisory support to MOEI.



## Some country updates on NBSAPs Enabling Activities GEF projects



#### Bahrain

- 1. National Biodiversity Indicators workshop and report completed (Dec 2011)
- 2. Stand alone project although SIDS
- 3. PCA under final discussions
- 4. Recently ratified CITES and Cartagena Protocol, Dugong MOU and due to limited resources is placing high priority on MEA synergies in targets.
- 5. Arab regional WHC center established in Bahrain
