## **NOTIFICATION**

Madam / Sir,

Informal Consultation on the impact of genetic use restriction technologies on indigenous and local communities and Farmers' Rights

At its fifth meeting, held in May 2000, the Conference of the Parties requested the Executive Secretary, in paragraph 29 of decision V/5, to discuss with organizations with relevant expertise and representatives of indigenous and local communities the potential impacts of the application of genetic use restriction technologies (GURTs) on those communities and on Farmers' Rights, and to prepare a report to be considered by the Conference of the Parties. The sixth meeting of the Conference of the Parties will be held in The Hague, the Netherlands, from 8 to 19 April 2002. GURTs will be considered under agenda item 16 of the meeting: "Thematic programme of work – progress report on implementation: agricultural biological diversity".

The Conference of the Parties requested that the discussions on potential impacts of GURTs take into account the revision of the International Undertaking on Plant Genetic Resources for Food and Agriculture to keep, use, exchange and sell seed or propagating material. On 3 November 2001, the International Treaty on Plant Genetic Resources for Food and Agriculture was adopted as a legally binding instrument.

I have the honor to inform you that, pursuant to decision V/5 of the Conference of the Parties, an informal consultation will be held on **3 February 2002**, prior to the second meeting of the Ad hoc Open-ended Inter-sessional Working Group on Article 8(j) and related provisions of the Convention, at the International Civil Aviation Organization, in Montreal. The results of the consultation will be reported to the above mentioned meeting of the Working Group on Article 8(j), which will take place in the same location, from 4 to 8 February 2002.
