Sujet: Accès et partage des avantages: Composition du groupe d'experts techniques chargé de se pencher sur l'examen d'un certificat d'origine/de source/de provenance légale reconnu à l'échelle internationale

Madame/Monsieur,

Lors de sa huitième réunion, qui s'est tenue à Curitiba, Brésil, la Conférence des Parties a décidé, au paragraphe 1 de la décision VIII/4 C, de « former un groupe d'experts techniques afin d'étudier et d'élaborer les choix possibles de forme, d'intention et de fonctionnement d'un certificat d'origine/de source/de provenance légale reconnu à l'échelle internationale, sans porter atteinte à leur bien-fondé, et d'en analyser l'aspect pratique, la faisabilité, les coûts et les avantages, afin de réaliser les objectifs des articles 15 et 8 j) de la Convention. »

Au paragraphe 2 de cette même décision, la Conférence des Parties a également décidé "que le groupe d'experts offrira une représentation régionale équilibrée et sera formée de 25 experts nommés par les Parties et de sept observateurs provenant, entre autres, des communautés locales et autochtones, de l'industrie, des institutions de recherche/pédagogiques et des jardins botaniques, et autres détenteurs de collections *ex situ* et de représentants d'organisations et accords internationaux compétents, et *prie* le Secrétaire exécutif de recommander la liste d'experts et d'observateurs choisis aux fins d'approbation par le Bureau. »

Par le biais de la notification 2006-030, en date du 8 mai 2006, et à la lumière des informations énoncées ci-dessus, le Secrétaire exécutif a invité les Parties, les communautés autochtones et locales, les organisations internationales compétentes ainsi que les parties prenantes concernées, à nommer des experts et des observateurs susceptibles de faire partie du groupe spécial d'experts techniques qui se penchera sur l'examen d'un certificat d'origine/de source/de provenance légale reconnu à l'échelle internationale. En date du 15 septembre 2006, le Secrétariat avait reçu 73 nominations. Sur la base de ces nominations, 25 experts et 7 observateurs ont été sélectionnés en fonction de leur expertise, en respectant une répartition équitable entre les régions géographiques, tout en assurant le respect de l'équilibre entre hommes et femmes. La liste des experts sélectionnés a par la suite été approuvée par le Bureau.

À l'attention des correspondants nationaux de la Convention et des correspondants nationaux pour l'accès aux ressources génétiques et le partage juste et équitable des avantages résultants de leur utilisation.

MEETING OF THE CO-CHAIRS OF THE WORKING GROUP ON ACCESS AND BENEFIT-SHARING AND THE SECRETARIAT OF THE CONVENTION ON BIOLOGICAL DIVERSITY Montreal, Canada 7 September 2006

Summary Report

1. Mr. Fernando Casas (Colombia) and Mr. Timothy Hodges (Canada), the Co-Chairs of the Ad Hoc Open-ended Working Group on Access and Benefit-sharing, who were appointed by the Conference of the Parties to the Convention on Biological Diversity at its eighth meeting, visited the premises of the Secretariat of the Convention, in Montreal, for a one-day meeting on 7 September 2006. The programme of the visit is contained in annex I. The discussions that took place during the visit are summarized below.

I. Meeting with all SCBD staff members

2. The Co-Chairs held a meeting with all members of the staff of the Secretariat. The Executive Secretary welcomed the Co-Chairs, who then informally gave a presentation on the ABS process from a personal historical perspective and shared their vision on the ways and means to ensure a successful implementation of the mandate given by the eighth meeting of the Conference of the Parties in Curitiba, Brazil, in March 2006. Expressing gratitude to the Executive Secretary for an early opportunity to meet, the Co-Chairs stressed the cross-cutting nature of the proposed international regime, underscored the regime's potential to positively effect the objectives of the Convention, and called on all staff members to provide their support.

II. Working session with Executive Secretary

3. The meeting with all members of the staff was followed by a working session between the Co-Chairs and the Executive Secretary. During this session, the suggested dates and venues of the fifth and sixth meetings of the Ad Hoc Open-ended Working Group on Access and Benefit-Sharing were discussed. The fifth meeting of the Working Group has been now proposed to be held back to back with the fifth meeting of the Ad Hoc Open-ended Working Group on Article 8(j) and Related Provisions of the Convention, in Montreal, respectively from 3 to 7 September 2007 and from 10 to 14 September 2007. The sixth meeting of the Working Group on Access and Benefit-sharing would be held in Montreal from 21 to 25 January 2008.

4. Concerns were expressed by the Co-Chairs that, because of financial considerations, the Budget Committee at the eighth meeting of the Conference of the Parties had decided that the Working Group on Article 8(j) would be held back to back with the fifth, rather than the sixth, meeting of the Working Group on Access and Benefit-sharing. While recognizing the constraints of the international calendars and budgets, the Co-Chairs expressed regret over the possible effect this may have in limiting the time available in the inter-sessional period to Indigenous and local community representatives in preparing for the two working group meetings. The Co-Chairs recommended the Bureau carefully consider this and other practical implications of holding these two meetings back to back. They volunteered that, in future, in addition to financial implications, other practical and strategic considerations could be usefully taken into clear account in planning future meetings of the Working Group on Access and Benefit-sharing. The merits of holding the sixth meeting of the Working Group on Access and Benefit-sharing in a developing country was also highlighted. The Executive Secretary was invited to liaise with potential host countries and to keep the Co-Chairs regularly informed of developments on this issue.

5. The Co-Chairs and the Executive Secretary also discussed the agenda, the organization of work and the draft list of potential participants for the meeting of the Group of Technical Experts on an Internationally Recognized Certificate of Origin/Source/Legal Provenance to be held in

Lima, Peru, from 22 to 25 January 2007. The Co-Chairs took note with appreciation of the documents prepared by the Secretariat, including the suggested list of experts and observers to be submitted for approval to the members of the Bureau of the Conference of the Parties, based on nominations received from Parties and relevant organizations and stakeholders. The Co-Chairs stressed the importance of the criteria of expertise and relevant experience in finalizing the list of participants. They also noted the initiative of the United Nations University (UNU), with the support of the Governments of Peru and Canada, to convene a stakeholder forum prior to the expert meeting under the Convention.

6. The Co-Chairs stressed the need to ensure a successful and meaningful outcome of this first expert meeting called by the Conference of the Parties. Its outcome would determine the usefulness of using such expert meetings to address specific issues in the implementation of the Curitiba mandate. Noting the broad scope of the terms of reference established by the Conference of the Parties for the meeting, the view was expressed that, in future, the terms of reference for such expert groups could be narrowed to better ensure substantive results.

7. The Co-Chairs also discussed the draft agenda and the organization of work of the fifth meeting of the Working Group on Access and Benefit-sharing. It was agreed that the agenda and the structure of the meeting should, foremost, be focussed on ensuring progress in the negotiation of the international regime and that the Committee of the Whole appears to be the optimal approach to achieving this aim. As well, the possibility of creating a single sub-committee of the whole or establishing two sub-committees was discussed in the context of initiating a substantive discussion on the "means" of implementing and/or further establishing the International Regime (i.e., the technical and financial means in addition to the related broad challenge of capacity-building). However, it was recognized that further consideration of possible approaches to the agenda was required after consultation with regional groups by the Co-chairs and discussion by the Bureau.

8. In discussing the conduct of future meetings on access and benefit-sharing, the Co-Chairs stressed their commitment to working together as a team. They also expressed the view that consultations with regional groups will be critically required before finalizing the organization of work for the fifth meeting of the Working Group. They again underlined that sufficient time should be devoted to the committee of the whole with a view to encouraging a holistic approach to the negotiations.

9. The Co-Chairs also discussed ways and means to invite, through the Conference of the Parties at its ninth meeting, and SBSTTA, at its fourteenth and fifteenth meetings, scientific, technical and technological advice on relevant ABS issues falling under its mandate. The potential contribution of SBSTTA on issues related to transfer of technology in particular was highlighted.

10. The Co-Chairs expressed the strong view that inter-sessional consultations with regional groups and others are essential to ensuring the success of the Curitiba mandate. They appealed to the Executive Secretary to liaise with donors to raise financial resources for the facilitation of such consultations prior to and after the fifth meeting of the Working Group. The possibility of convening a consultative meeting in Geneva was also discussed.

11. Also addressed was the question of outreach activities on issues related to access and benefit-sharing in the context of the Global Initiative on Communication, Education and Public Awareness (CEPA). The possibility of selecting the theme of access and benefit-sharing for the 2010 International Day for Biological Diversity and the need for capacity-building were also discussed. Finally, the participation and involvement of the Co-Chairs in the meetings of the Bureau of the Conference of the Parties, in an ex officio capacity, were considered important.

III. Meetings with members of the staff of the Secretariat

12. Following a working lunch with the Executive Secretary, the Co-Chairs held a working session with staff members of the Secretariat responsible for capacity-building and for access and benefit-sharing. There was a general exchange of views on capacity-building needs, with reference to the action plan on capacity-building for access to genetic resources and benefit-sharing adopted by the Conference of the Parties in decision VII/19. This was followed by discussions regarding preparations for the Group of Technical Experts on an Internationally Recognized Certificate of Origin/Source/Legal Provenance, as well as inter-sessional consultations to be carried out by the co-chairs and collaboration with the Secretariat.

IV. Conclusion

13. The meetings with the Co-Chairs of the Working Group on Access and Benefit-sharing provided an excellent opportunity for the Secretariat to better understand the expectations of the Co-Chairs in fulfilling their heavy responsibility. It also provided a timely opportunity to discuss the preparation of the Group of Technical Experts on an Internationally Recognized Certificate of Origin/Source/Legal Provenance, as well as the preparation and organization of work for the fifth meeting of the Working Group on Access and Benefit-sharing. It was felt that the regular convening of similar consultations between the Secretariat and the Co-Chairs is important to ensure an adequate preparation of the processes related to access and benefit-sharing. The Executive Secretary was requested to assist in mobilizing additional financial resources for the convening of similar consultations.
