### Lists of Parties covered by the subregional technical and scientific cooperation support centres

Dear Sir or Madam,

Following the Secretariat's consultations with Parties to the Convention and its Protocols, as referenced in notification [2024-058](#), I am pleased to communicate the confirmed list of Parties to be supported by the subregional support centres of the technical and scientific cooperation mechanism, contained in section 1 of the annex to the present notification.

I would like to thank Parties that have confirmed to the Secretariat the subregional support centre with which they wish to collaborate, and invite those that have not yet responded to the Secretariat's communication and are therefore not included in the list, to communicate their wish at their earliest convenience, by e-mail to [secretariat@cbd.int](mailto:secretariat@cbd.int) with copy to [technicalcooperation@cbd.int](mailto:technicalcooperation@cbd.int). With regard to the subregional support centres in Europe, where there was significant overlap in the country coverage, the Bureau of the Conference of the Parties (COP Bureau) requested the selected support centres in Europe to propose a workable solution. In response, three of the centres, namely the IUCN Centre for Mediterranean Cooperation, the Joint Research Centre (JRC) of the European Commission and the Royal Belgian Institute for Natural Sciences, agreed to partner together under the leadership of JRC. Under this collaborative arrangement, the JRC will provide a single-entry point for the Parties concerned.

Furthermore, the IUCN Regional Office for Eastern Europe and Central Asia (IUCN ECARO) and the Regional Environmental Centre for Central Asia have agreed to work together in a collaborative arrangement, whereby IUCN ECARO will serve as the single-entry point for the concerned Parties in Eastern Europe and Central Asia.

The indicative list of Parties that may be covered under the above two arrangements is provided in section 2 of the annex. In the coming weeks, the subregional support centres will contact the respective Parties to discuss the next steps, including identification of the initial priority needs and options for technical cooperation, which will form part of the first biennial work plan of the support centres.
