Saint Lucia is a small developing state highly dependent on limited natural as well as financial resources. As such, although the country has recognised the need to conserve and protect its biodiversity, there are few mechanisms currently in place to ensure this.

Notably, the island has completed and adopted its National Biodiversity Strategy and Action Plan in which specific procedures are outlined to address these issues. But, finances and other resources are yet to be identified to effectively implement this plan.

Further, a full-time national secretariat to coordinate the activities pertaining to this convention is not yet in place, and thus, many of the work programmes, decisions, annexes etc. have not yet been completely reviewed, making tasks required to be carried out under this convention difficult for the moment. The COP has established programmes of work that respond to a number of Articles. Please identify the relative priority accorded to each theme and the adequacy of resources. - A CD-Rom-based resource on the plant resources of St Lucia was recently developed by a private researcher affiliated with the Forestry Department of the Ministry of Agriculture, Forestry and Fisheries. This resource contains some 1,400 indigenous and exotic species.
- The biodiversity country study report contains a significant body of data on the plant and animal resources of the country.
- The National Herbarium is endeavouring to make information more available to interested persons/agencies.

47. Cooperation in this regard is limited to informal agreements with regional and international educational, government and NGO institutions granting permission to carry out research in St Lucia and/or its national waters. Such research is usually carried out in collaboration with the relevant local management body.

However, some formal agreements do exist for example the CARICOM region has benefited significantly in terms of fish stock assessments, training and institutional capacity building in fisheries related areas under the CARICOM Fisheries Resource Assessment and Management Programme. **48.** Information exchange, vis-à-vis case studies, have been circulated regionally and internationally on the St Lucia Parrot (*Amazona versicolor*), St Lucian Whiptail lizard (*c. vanzoi*), sea urchins, cetaceans, corals, lobsters, and a few others.

74. In terms of regulating the use of resources, there are certain biological resources that have been given a significant amount of attention, e.g. marine resources and the St Lucian Parrot; however, there still exists some resources for which regulatory management mechanisms are inadequate e.g. Queen Conch, lobsters, shared pelagic resources, and ecosystems such as beaches and mangroves.

75. A System of Protected Areas for St Lucia was developed in 1992 by the St Lucia National Trust but was never adopted in full by the Government. However, management plans are currently being developed for a few of the protected areas recommended in this document and there are several other legally declared protected areas currently in place. Many of these protected areas lack active management plans.

Further comments on implementation of this Article

132. Most of the indicatives in this regard have not been through direct bilateral cooperation between countries. St Lucia has typically benefited through regional programmes that facilitated exchange of genetic resources e.g. of banana and food crop germplasm though the Windward Island Banana Development and export Company, and the Caribbean Agricultural Research and Development Institute.

The most recent programmes to exchange plant germplasm for ex situ conservation programmes has been through the Taiwanese and Chinese Governments.

Animal genetic resources have been exchanged for ex situ conservation through an ongoing program with the Jersey Wildlife Preservation Trust in the United Kingdom, with respect to the conservation of the St Lucian Parrot and the St Lucian Whiptail Lizard, both of which are critically endangered.

133. On example of the reintroduction of threatened species is the translocation of a small population of St Lucia Whiptail lizards from one offshore island which represented the world range for the species, to another offshore island where a viable population has now developed.

Another example is the establishment of *Coccothrinax barbadensis* (used in broom making) from ex situ collections back to its wild range.

Further comments on implementation of this Article

- The St Lucia National Trust developed a system of parks and protected areas in 1992, but this was not adopted in full by the government.
- A number of marine reserves have been declared under the Fisheries Act but many of these lack management systems in place.
- The establishment of two marine management areas (zoned coastal areas) along the west coast are aimed at protection and conservation of coastal and nearshore resources. The process used to establish these areas and maintain them involved wide spread consultation and continues to allow ongoing participation by users and other interest groups in management of the area. The management strategy used to create and maintain these areas has been deemed successful and the areas serve as well known case studies for stakeholder participation and management of natural resources - the Soufriere Marine Management Area Case Study was submitted to the executive secretary.
- Some linkages with other conventions with regard to the protection and conservation of biodiversity do exist e.g. the identification of areas for protection under the Convention for Dessertification a report has been submitted to the secretariat of this convention but is relevant to CBD.
- Some action has been taken by the St Lucia Heritage Tourism to utilise while protecting certain fragile areas and areas of high biological diversity. Numerous pieces of legislation and policies supports sustainable tourism e.g. the National Conservation Act of 1999.
- Public awareness programmes, for example those employed by the St Lucia Heritage Tourism, the Department of Fisheries and Forestry Department, are producing positive results in that they are enabling the adoption of conservative and protective measure in tourism related ventures.

- St Lucia assists individuals and agencies whom request access to resources for research purposes. For example, laboratory and office facilities, and technical assistance are made available in some cases. Agreements between parties may be formal or informal.
- In general, St Lucia is fast becoming aware of the benefits to be gained by its local genetic resources and as such are moving towards formalising policies and programmes regarding use and research of genetic resources.
- Information on issues relating to intellectual property rights, access to genetic resources and benefit sharing are outlined in a document titled "Intellectual Property and Traditional Knowledge Related to Genetic Resources" which was submitted to the Executive Secretary.
- Facilities for in vitro germplasm conservation and some field genebanks have been established. However, maintenance is poor due to lack of human and financial resources for maintenance of ex situ collections. Also needed is training in field genebank management and minimal growth techniques.
