The Solomon Islands has not produced a National Biodiversity Strategy and Action Plan. There is a State of Environment Report (1992). There is also a National Environmental and Management Strategy that is still the blue print for environmental management in the country. New legislation have been developed and put in place at the national level. The Medium term development Strategy has been a national guide in implementation of all domestic activities. Various sectoral agencies have their own action plans/policies, which have been used or consulted in this report. Regional organisations in the South Pacific region have played a much a significant role in assisting the countries of the region in implementing global programs and legal instruments. International NGOs and other civil society organisations have also played some major role in this respect.

The regional organisations referred to above include the following: The South Pacific Regional Environment Programme, South Pacific Geoscience Commission, South Pacific Forum, Pacific Community and Tourism Council of the South Pacific, University of the South Pacific.

The international NGOs include: WWF, FIELD, Greenpeace, Conservation International, IUCN, etc

During the last two years, Solomon Islands has experienced a period of instability with the ethnic crisis on the island of Guadalcanal. This has caused a lot displacement for many people and a worsening economic situation and is a setback for conservation activities. The chronic shortage of resources caused by this worsening economic condition, therefore, could not allow the desired implementation of relevant activities or even the comprehensive review and compilation of this report.

### Further comments on implementation of these decisions

More taxonomy work is done in Botany than in other fields. Some needs assessment has been carried out for the herbarium including an action plan on ethnobotany. Recent staff movements and other problems related to the ethnic tension have affected the work of the herbarium. There is hardly any taxonomist in the country even though there is some bare capacity within the forestry sector. Solomon Is recently participated in the efforts to establish the regional loop (PACINET) as promoted by CAB International.

Most of the local NGOs are involved in community awareness and some a very effective network through out the country involving community personnel. Even though there is still to be produced a Biodiversity Strategy, most other sectoral and regional thematic strategies which the country is implementing integrates environment and awareness programmes. Most programmes always have an awareness component.

The public media have ongoing programmes on environment and biodiversity issues running every week. The Solomon Islands Broadcasting Corporation runs two programmes every week. The Solomon Islands daily, The Solomon Star frequently runs features on environment and biodiversity.

The programmes in Medium Term Development Plan integrate awareness and education programmes. Resources however are still very limited.

Institutional weaknesses, has made it difficult even to co-ordinate action at the national level. There is still a lack of a national framework that could guide the implementation at the national level. The office of the national focal point lacks the resources to effectively co-ordinate implementation of the requirements of the convention. Even though donor assistance has been received for some activities, more could be done if new assistance is provided.
