Please provide summary information on the process by which this report has been prepared, including information on the types of stakeholders who have been actively involved in its preparation and on material which was used as a basis for the report

Preparation of the report was one of

the national biodiversity strategy and action plan complementary activities

The start was through communication by exchange of letters with the parties concerned with biodiversity conservation. These parties were the Ministries of, Agriculture, High Education, Irrigation, Tourism, Interior, in addition to the Ministry of State for Environmental Affairs, which is the concerned, coordinating and supervising body for the fulfillment of the biodiversity convention. It also included public organizations such as the Unions of, Women, Youth, Peasants, and Students, Arab and International organizations working in Syria (ACSAD, ICARDA), and domestic societies (the Damascus Friends Society, the Environment Friendly Society in Ar-Raqqa, the Syrian Society for the Protection of the Environment, Scientific Life Society).

The aforementioned parties were requested to nominate their representatives in the National Report Preparation Committee. Then these representatives were invited to a meeting designated for acquainting with the questions mentioned in the report and establishing the appropriate mechanism for responding. Then the questions were distributed among the representatives of the concerned parties who were asked to answer them after reverting to the standard data particular to each concerned party.

Following a period of two months of deliberation and dialogue with the concerned parties, the National Workshop convened on 17/2/2002. The meeting was attended by all concerned parties who gave their answers to all the questions listed in the second National Report Format.

Please provide information on any particular circumstances in your country that are relevant to understanding the answers to the questions in this report

In spite of the conservation system implemented by the Arabs for achieving sustainable growth of the pastures on which the animal wealth is dependant, and although there are many rules that regulate the investment and management of biodiversity reserves and components in Syria, modern concepts of biodiversity were not introduced in Syria until the beginning of the last decade. Since then, there has been continuous concern, on both the formal and public levels, of biodiversity and its components, laying down strategies for its conservation, and establishment of natural, forested, grazing, marine and fresh water reserves as well as wetlands.

It is worth mentioning that Syria is an agricultural and developing country and that locals in rural areas are heavily dependant on the natural resources found in forests, steppe (Badia), and around rivers, for their daily livelihood (food, medical plants, fuel, etc). This lead to increased pressure on the biodiversity components and on ecosystems and hence their nos. declined and became at the risk of deterioration and extinction, particularly at heavily populated areas.

Further comments on work programmes and priorities

Regarding Q1: giving priority to the biodiversity protection in the inland water was not given the required concern. There are clear interventions upon the aquatic assemblies and wetlands such as dams. There are various marshes, wetlands and rivers.

Regarding Q3: the legislations governing protectorates and protection are acceptable, yet the application of these laws remain inadequate due to the great pressures on the biological resources in aquatic resorts, and the tourist pressures on coastal areas.

Regarding Q5: the agro-biodiversity is considered a very significant issue in Syria and there are serious attempts to protect it "In-sito" and "Ex sito", yet the available resources are inadequate.

Regarding Q7: the forest biodiversity is important, therefore many protectorates and preservation areas were established, yet the financial support to meet the required technical requirements for protection, achievement of a sustainable investment, and securing replacements for exploitation of forests by the local inhabitants remain insufficient.

Regarding Q9: biodiversity in these areas is very important as they are major grazing areas (pastures) for the animal wealth, which is very significant on the national economic level. The mountainous areas were given special attention where many protectorates and preservation areas were established.

Additions:

The reserves mentioned in the foregoing ecosystems and listed in the format are distributed as follows:

- one reserve of wetlands
- 14 reserves of natural forests
- 30 reserves of pastures distributed over the Syrian desert (Badia)..

These locations require technical and financial support to realize the optimal criteria of protection.

There is also an agro-biodiversity project in two areas in Syria (Slenfe, Al Swaidaa); its objective is to conserve vegetal genetic resources.

Regarding Q72: yes, there is a regulation governing protected areas (reserves), and this regulation has progressed with acceptable steps; there are 14 declared reserves, whose administrative and scientific plans are under completion, yet further support is required to achieve such completion.

Regarding Q73: there are certain general principles associated with the rules that support the establishment of reserves; currently, efforts are in place to develop and improve these principles and rules.

Regarding Q77: yes, through re-afforestation; there is a special Directorate in charge of re-afforestation works.

Regarding Q78: yes, some species are under proliferation; there is a special bank for the seeds of plants and trees, and there is also a vegetation compound to serve this bank.
